

RESULTS

Stadium Club Mixed Triples

On 11-12 July the club held the annual Stadium Club Mixed Triples Championship. What a great competition it was between the eight strong teams with a very good standard of bowls seeing some nail biting finishes.

At the end of Saturday there were just three teams left in the competition - each with one life left.

On Sunday morning Richie Muir (s), Alice Turnbull and Jo Stock played Bill Turnbull(s), Marilyn Steel, Kathryn Mitchell in what turned out to be a real cliffhanger.

Bill Turnbull's team got away to a dream start with a 4 on the 1st end and built on that to lead 6-1 after 4 ends. Richie's team regrouped and worked well together with accurate draw shots to lead 10-7 with just 2 ends to go. Bill Turnbull's team had other thoughts, and in a very tense last two ends they scored 3 shots to tie the game up at 10-10 and force an extra end to be played.

With the winner of the extra end to go into the final, it was all on for this deciding end. With only the skip's bowls to be played, Bill Turnbull's team held shot and despite Richie Muir's efforts, took out the match and advanced into the 14 end final where they were pitched against Ken Allison's team of Bob Steel and Yvonne Gale.

Early on there was very little between the teams and after 4 ends the score was 2-2. Then things changed somewhat with Ken Allison's team all bowling consistently accurate bowls and that created continuing problems for Bill Turnbull's team.

After 11 ends Ken Allison's team had built a substantial lead of 14-4. Bill Turnbull's team rallied and won the next two ends to be 8-14 down going into the final end. Getting 6 to force an extra end was always going to be a huge ask. Bill Turnbull, in good humour, jokingly said "can anyone tell me how we can get a 6?". The answer from one of the crowd of onlookers was "phone a friend!"

After some deliberation over where all the bowls were, Bill said, "if I come in there and rub off that bowl..... go between those two bowls and take out that opposition shot bowl.... we could get 6!

For a moment it looked as if the plan might succeed as Bill made a brilliant attempt to follow his plan, but it wasn't to be. Great attempt though. Final score 15-8. Congratulations to Ken Allison, Bob Steel and Yvonne Gale who are this year's champions

Stadium Club Mixed Pairs

The toasty warm Wanaka Bowling Club's Stadium has shown to be a great place to go at this time of the year with it being so bitterly cold. The weekend of 18-19 July was a good example of that when the Stadium Club Mixed Pairs were held with a full field of 10 teams competing for the title.

At the end of Saturday's play the field had been narrowed to three teams after a long day's play. Play resumed on Sunday morning with Richie Muir and Heather Malcolm, who had one life left, playing the unbeaten Ken Allison and Alice Turnbull with 2 lives.

Richie Muir and Heather Malcolm could do no wrong and with consistently accurate bowling ran out convincing winners by 17-4.

This left Ken Allison and Alice Turnbull to play Bill Turnbull and Jo Stock for an opportunity to play Richie Muir's team in the final. What a close game this turned out to be. Team Turnbull got away to a sound start and bowled well to lead 5-1 after 3 ends and 10-4 after 8 ends. They were looking good. However, on the next end Ken Allison, with his last bowl of the head, facing another lost end, played an aggressive bowl that scattered bowls but gave him 3 shots to trail by 7-10.

The game then changed dramatically and team Allison won the next 2 ends to go into the final end at 10-10. One further shot on the 12th and final end gave the win to Ken Allison and Alice Turnbull. A game of two halves!

The final between Ken Allison/Alice Turnbull and Richie Muir/Heather Malcolm was played over 16 ends.

Team Allison started well and won the first 2 ends to lead 4-0. After 6 ends the teams were even on 7-7 but Team Allison worked well together and won the next 3 ends to lead by 12-7 and look strongly placed. Team Muir had other thoughts and poured on the pressure and take the ascendency over the next 6 ends to lead 15 -12 going into the final end. Richie Muir bowled tactically to prevent dropping a 3 and the game ended at 15-13 to Richie Muir and Heather Malcolm.

PRESS RELEASE FROM AUCKLAND BOWLS

Auckland Bowls General Manager Steven Yates is delighted to announce the securing of several World Class Bowlers for its **Premier Ladies Open**, to be held on 26th and 27th September 2020.

Headlining the participants is current World and NZ Singles Champion **Jo Edwards**. Jo is one of New Zealand's greatest ever bowlers. In two decades, she's amassed two World Bowls titles, three Commonwealth Games gold medals, a record-equalling six World Cup singles crowns and countless other international honours. The Nelsonian is also the country's most capped player, having become the first New Zealander to reach 600 caps in 2019.

Joining Jo Edwards in the WPOS is **Val Smith** who has also won multiple National Titles and represented New Zealand at The Commonwealth Games, World Championships and Asia Pacific Championships, picking up several medals. Val is recognised as one of the most feared singles players in the country.

Selina Smith will return in 2020 to defend her title where she overcame fellow Blackjack teammate **Deb White** in last year's final. Selina had an outstanding season last year representing her country at the Trans-Tasman challenge in the Gold Coast in February 2020. Selina has also previously represented Auckland Bowls at Representative Level. Unfortunately, due to other commitments, Deb White is unable to return this year.

Fellow Blackjack **Wendy Jensen** has also accepted an invitation to have a crack at this prestigious title and again had a very successful 2019/2020 season. Wendy capped a fine 2018/2019 season by being recalled to the national set-up for last year's Asia Pacific Championships after last representing NZ in the early 2000's. Like Selina, Wendy has also previously represented Auckland.

World Under-25 Singles Champion **Paris Baker** will also line up in this year's event. After reaching the Semi-Finals last season in a very tense battle, she was just pipped at the post. Auckland Bowls had the privilege of welcoming Siosifa Takitoa Taumoepeau, Tonga's Head of Sport and Recreation, to last year's event. After stepping off the plane and jumping into a cab, he arrived just in time to cheer on Paris. Paris is a current member of the Auckland Bowls Open Women's Representative Team.

Yates believes this is the strongest line-up ever assembled for this event and it is designed to encourage our local Female Bowling Community to enter, whilst also providing the opportunity of playing against some of the best Bowlers in NZ and the World.

The event will also be Livestreamed on our Auckland Bowls Facebook and Website so if you can't make it to one of our venues over the weekend, you will still have the opportunity to watch some outstanding Bowls.

The Headquarters and playing venues are yet to be determined and will be announced in the very near future. Entries will open on Friday 1st August 2020, so mark these dates on your calendar and make sure you get your entry in as soon as possible (to avoid disappointment) and have a crack at the best.
